





- i. There will be no Government assistance of grant in aid of any nature, either financial or non-financial, in any manner for any colleges/ any streams/ any subjects opened in self-financing mode.
- ii. The Colleges and the faculties (existing faculties/ to be hired or engaged) are required to submit a signed affidavit stating their understanding that they will not seek any financial or non-financial aid or support of any nature from the Govt. in future, and are agreeing to the terms and conditions of functioning in the self-financing mode without making any claims for Government support.
- iii. The College should clearly mention in the advertisement for the engagement of faculties that the concerned college is functioning in self-financing mode and no financial or non-financial support or grant of any nature will be extended to them from the Government in future. Engagement of faculties should be done in a transparent and qualitative manner and the Governing Body of the Non-Government College shall invite the principal or his representative of the nearest Government College at the time of recruitment. However, this process will not entitle any one to claim for financial support or grant of any nature in future from Government.

The Professional Colleges shall contribute a Non-refundable fee of Rs. 2.00 Lakhs through treasury challan shall be deposit by the College under the head "Demand No.38-8229-Development & Welfare Funds-101-Development Funds for Educational Purpose-(A)-Orissa Loan Stipend Fund (Receipts) towards loan stipend fund of the state Government at the time of either permission or recognition..
